# Berwick Area Joint Sewer Authority REGULAR MEETING MAY 10, 2017

The monthly scheduled and advertised meeting of the Berwick Area Joint Sewer Authority (BAJSA) was called to order by Chairman Gary Pinterich at 6:00 pm. The pledge of allegiance to the flag was presented.

# APPROVAL OF MINUTES

## PUBLIC INPUT

Larry Holloway from 24 Arbor Street in Berwick was present from the public to discuss that the grading on the corner or Arbor & Elm Streets is now higher since the storm water separation project has been completed and water is now running into his yard when it rains. Engineer Dennis Peters was on-site at the premise on May 4, 2017 during a rain storm and video recorded where the water was running. It was explained to Mr. Holloway that the water is running on the opposite side of the street from his property and at no given time during the 15 minutes that Dennis Peters was recording, did the water cross over onto Mr. Holloways side of the road. This is a storm water situation where another inlet may need to be installed and connected to the drywell, and therefore, the Borough of Berwick would need to be contacted.
